The City of Kyle is hosting a groundbreaking event to kick-off construction on the extension of Marketplace Avenue, the first of eight projects in the 2022 Kyle Road Bond program to begin construction. A ceremonial groundbreaking event will be held Tuesday, October 15 at 10 a.m. at the northern end of the project limits. Parking during the will be available on-site at 19121 Marketplace Avenue.

This 0.6 mile project will connect the northern and southern segments of Marketplace Avenue. The existing segment from FM 1626 to Old Bridge Trail will be widened to match the new section.

Parks, Recreation, and Open Space Master Plan Update

The City of Kyle is beginning the Parks, Recreation, and Open Space (PROS) Master Plan. This collaborative process invites all residents to envision, imagine, and plan the future of our parks, recreation activities, events, and trails.

The City of Kyle's Park Master Plan is a strategic blueprint designed to guide the development, management, and enhancement of Kyle's parks, recreational facilities, and open spaces over the next 10-20 years. This plan takes a comprehensive look at the current state of Kyle's parks, assessing existing facilities and identifying future needs based on community input, demographic trends, and environmental considerations unique to Kyle.

The internal process kicked off officially on August 20, 2024, and a timeline has been provided as we prepare to enter the community input phase in October. We look forward to working with the City Council, Parks Board, Trails Committee, stakeholders and entire community to produce the best plan to shape the future of parks and recreation in Kyle. The Community Garden at Post Oak is now open to the public! The garden is open seven days a week, sunrise to sundown. The Parks and Recreation Department would like to thank several city departments that assisted in making the garden a reality including Public Works, Engineering, Planning, and the Parks' Beautification, Maintenance and Trails Divisions.

The garden features ADA picnic tables and garden plots that were made possible as Eagle Scout projects completed by Eagle Scouts Joelsaac Pinales, Zachary Gamble, and Mason Chandler. The garden features 35 Garden plots including 4 x 8 x 1 plots, 8 x 12 x1 plots, ADA accessible garden tables and plots, a greenhouse, a tool shed, a pergola, picnic tables, compost, mulch and soil bin, deer fencing, herb and flower gardens, and a restroom.
