

## City of Kyle, Texas Notice of City Council Budget Meetings and Public Hearings For Fiscal Year 2025-2026

The Kyle City Council is scheduled to hold meetings and public hearings to discuss and approve the City's proposed budget for Fiscal Year 2025-2026 for all City Funds. This discussion and approval will cover the City's proposed budget for Fiscal Year 2025-2026 to include revenues, expenditures, fund balances for City Funds and other budget items such as property tax rates, water and wastewater service rates, storm drainage fee, other fees and charges for various City programs and services, capital improvement projects, requests for additional personnel, requests for new equipment and vehicles, and other budgetary items.

The proposed budget for Fiscal Year 2025-2026 is a complete financial plan for all City Funds, programs, services, maintenance and operations, and capital improvements plan activities for the 12-month period beginning October 1, 2025 and ending September 30, 2026.

The City Manager's proposed budget for Fiscal Year 2025-2026 for all City Funds, totals approximately \$603.5 million and includes 24.0 new positions for a total of 470.0 full-time equivalent positions. Of the total \$603.5 million proposed budget, the City's General Fund budget for Fiscal Year 2025-2026 totals approximately \$75.4 million for maintenance and operations and \$2.1 million for transfersout to the various TIRZ Funds for their proportionate share of estimated maintenance and operations portion of property tax revenues.
