II. LEGISLATIVE UPDATE

The City of Kyle's Legislative Program serves as a strategic framework to advance key initiatives, secure funding, and establish partnerships that support both current needs and long-term goals.

Recently, we received updates on several grant applications. Unfortunately, the City was not awarded the U.S. DOT Consolidated Rail Infrastructure and Safety Improvements (CRISI) grant, which would have funded essential road projects on Kohlers Crossing. However, promising funding opportunities remain for these projects, with \$48 million still under consideration for Kohlers Crossing through the Railroad Crossing Elimination (RCE) and Reconnecting Communities Pilot (RCP) grants. On a positive note, the City has been awarded the Energy Efficiency and Conservation Block Grant from the State Community Energy Program, providing \$76,000 toward sustainability initiatives. Additional successes include a \$131,750 award from the Catalytic Converter Grant Program to bolster public safety and a \$49,500 grant to continue supporting our Victims Liaison services.

Looking ahead for FY25, the City is expanding its legislative program to include every major project across all departments and divisions. Using our new open data and tracking system, we are actively developing project pages and pursuing grant opportunities focused on Water/Wastewater Operations, Parks and Recreation, Conservation, Mental Health, Transportation, and Arts and Culture.

Kyle Parks and Recreation Open Space (PROS) Master Plan

On October 21, the Parks and Recreation Department hosted the Parks, Recreation, and Open Space (PROS) Master Plan Public Meeting #1 at Mary Kyle Hartson City Square Park. This gathering marked a vital opportunity for community members to share their thoughts and ideas on the future of Kyle's parks and recreational spaces.

As residents arrived, they were welcomed by various informational booths that showcased two key initiatives: the Parks, Recreation, and Open Space Master Plan and the Kyle Sports Complex. This meeting was one of two community engagement sessions designed to gather valuable feedback during this important listening phase. The next will be on November 6 at 6pm at the Public Works Office for your next opportunity to have your voice heard!

The Parks, Recreation, and Open Space Master Plan aims to serve as a blueprint for enhancing existing parks while envisioning the future of Kyle's green spaces and recreational areas. Simultaneously, the proposed sports complex—funded by the November 2020 Park Bond and supported by a \$7 million match from Hays County—promises to deliver new sports and recreation amenities that will enrich the lives of Kyle residents.

The city is calling on its residents to play an active role in shaping these projects. Through public workshops and a citywide survey, individuals have the chance to voice their opinions and ideas, ensuring that the future of Kyle's recreational offerings reflects the desires of the community. As we move forward, we look forward to incorporating this feedback into our plans, creating a vibrant and inclusive environment for all to enjoy.


