II. COMPREHENSIVE PLAN ADOPTION

The Kyle Planning & Zoning Commission will hold a second Public Hearing for the Kyle 2030 Comprehensive Plan on Tuesday, January 9 at 6:30 p.m. The Kyle City Council will hold a Public Hearing and vote on the final adoption of Comprehensive Plan on Tuesday, January 16 at 7 p.m.

III. KOHLERS & KYLE CROSSING TRAFFIC SIGNAL

In an effort to immediately address the safety concerns and congestion at the intersection of Kohlers and Kyle Crossing, Kyle Public Works will begin installation of temporary traffic signals on Friday, Jan. 5. The signals will not change the traffic pattern at the intersection at this time. They will be set to flash red, and the stop signs will stay in place.

On Tuesday, Jan. 16, 2024 the traffic signals will be activated, and the stop signs will be removed. The intersection will then be controlled by the traffic signals. Prior to the signals being activated, the community will be notified through traffic alerts. The temporary traffic signals will remain in place until the permanent signalization improvements are made at the intersection. The permanent improvements are currently under design and utilities are being moved in preparation. (For more information see attachment on page 18)

IV. MENTAL HEALTH ACCESS RFP

V. PROPERTY TAX BILL ERROR

On January 2, the City became aware of a billing issue with the Hays County Tax Office that we contract with to prepare and collect our property tax bills. When preparing the statements this year, the County mistakenly used the City's old tax rate (\$0.5082) instead of the correct rate (\$0.4693).

Fortunately, no bills were mailed to residents. However the tax statements were posted online. And as a result, some residents could have seen the bills and paid the wrong amount.

The online statements have been corrected and anyone that paid their property taxes already will receive an automatic refund. Property tax bills with the correct tax rate will be mailed on Monday, Jan. 8.

VIII. DECEMBER WATER USAGE UPDATE

The below report provides total monthly real water production demands from June 2023 - December 31, 2023 including average daily demand for those months and the percent in increase or reduction month to month in order to capture the effects of more stringent watering restrictions and increased enforcement going into effect on Sept. 1, 2023.

Since Amended Stage 3 Drought Restrictions went into effect Sept. 1, 2023, there has been a 44.7% decrease in total monthly water production demand and a 42.85% decrease in average daily production demands resulting in a total monthly production decrease of 80,353,000 gallons in December 2023.

We thank all of our residents and business for doing their part in conserving water. However, we still have a long way to go until we're out of the drought and we're asking everyone to continue to do their part in conserving our water. SUBJECT: Kohlers Crossing/Kyle Crossing Temporary Traffic Signal Update

Following is an update on the progress of the temporary traffic signal installation at the Kohlers Crossing/Kyle Crossing intersection.

To recap, CP&Y (now STV) was engaged to develop a preliminary engineering report on March 1, 2022 for either a roundabout or a traffic signal at the referenced intersection. The report was presented to Council July 19, 2022. Based on the information presented, Council's direction at the time was to proceed with a temporary timber pole and cable traffic signal design. There was no development expected near the intersection and it was believed this design would minimize significant monetary loss in the future when permanent improvements are finally determined and installed. In the meantime, this temporary installation would assist in the operations of the intersection.

STV began design work after the Council approved Task Order #10 in September 2022. Originally the project schedule was to start construction in the late summer of 2023. Utility coordination began in February 2023. Multiple lines needed to be raised for the proposed installation. PEC has raised their line, but four separate and individual communication lines still need to be adjusted. We anticipate it will take at least two more months for the communication companies to complete their relocations.

In the meantime, Chick-fil-A's contractor has started construction on the northeast corner of the intersection and a site development plan has been submitted for a medical building on the southeast corner. PEC has also moved a corner pole, and new underground utilities have been installed at the corners. These utility changes have affected the design.

With these changes, we will need to redesign the temporary timber pole design. Currently, the design does not take pedestrian traffic into consideration nor the Vybe that is proposed through the intersection. The temporary traffic signal, we believe, will be in place for around 5 more years. After this period, the corners should be fully established, and the Kohlers Crossing Road

bond project will be further along to where we can develop a permanent improvement at the intersection.

To alleviate some of the traffic congestion at this intersection, we have determined Public Works' portable traffic signals can be installed at this intersection. Public Works will be setting up the portable traffic signals tomorrow (1/5/24) in a flashing mode. They will be activated on January 16, 2024.

With the portable signals installed, STV will revise the current design to accommodate pedestrians and the Vybe improvements while we continue to work with the utility providers to complete their adjustments. STV estimates it will take them 3 months to revise the plans.

Revising the current design to accommodate pedestrian traffic and the Vybe will require Council approval of a supplement to STV's Task Order #10 for the redesign of the plans to accommodate pedestrians and the Vybe. The design change will cost approximately \$80,000.00. We also estimate the temporary timber pole traffic signal construction cost would increase by \$180,000 for an overall cost of \$400,000.

Increase Access to Mental Health Services for Residents Under the Age of 18

Request for Proposals

The City of Kyle, Texas is seeking proposals that can increase access to mental health services and substance use disorders for residents of the City of Kyle and Hays County, Texas that are under the age of 18.

Background

In May of 2022, Hays County ("the County") engaged Meadows Mental Health Policy Institute to conduct a Mental Health Needs Assessment to assess the community's mental health system and provide recommendations to increase the availability of resources to meet the needs of residents within the County. The assessment identified potential gaps in service and opportunities for improvement across an array of mental health services. In particular, the assessment identified several issues related to children including increased concerns regarding substance abuse and mental health, lack of access to services, lack of resources available to providers and families, and a lack of support in schools. Additional information can be found in the presentation attached to this RFP. Based on these findings, the City of Kyle ("the City") has determined a great need for increased access to mental health services in the City for residents under the age of 18. As such, the City desires to bridge this gap by partnering with service providers in this field.

Proposed Project

The City of Kyle is soliciting proposals that aim to increase access to mental health services and substance abuse disorders for residents under the age of 18.

Proposals should identify and address the needs of residents under the age of 18 within the community. In coordination with the City, responders must be able to successfully develop a plan to increase access to mental health services for residents under the age of 18 and subsequently implement the plan. The City has identified some funding in the FY 2023-24 budget and Hays County may be willing to financially participate in a partnership depending on the cost and services offered. Potential grant funding is also available depending on the services and approach that is recommended. As such, the proposal submitted should provide a plan on how funding and services could be scaled according to additional funding and partnerships that can be leveraged in the process over time.

The City anticipates this program to be created via a cooperation agreement between the City, the County, and the service provider. This RFP is intended for agencies with the necessary capacity and experience to successfully design and implement a plan to increase access to



mental health services for residents of the City of Kyle and Hays County that are under the age of 18. This RFP opens January 8, 2024, and all proposals are due no later than February 2, 2024 at 5:00 PM.

Qualification Requirements

- Previous experience providing mental health services to the identified population, including:
 - o Providing services to residents under the age of 18;
 - Developing and implementing successful strategies to engage the identified population; and
 - o Working with families/caregivers to identify, understand, and address early signs of mental health disorders/behaviors and substance use disorders.
- Understanding of and experience with the priority population, including:
 - Needs, risk factors, and strengths;
 - o Developmental and age-related issues; and
 - o Any challenges with engagement.

Scoring Criteria

Your proposal will be evaluated based on the clarity and detail provided related to each of the following scoring criteria. A maximum of 100 points will be awarded to each proposal and will be used as part of the recommendation process.

Agency readiness/capacity (0-15 points)

- Overall clarity and detail of agency experience with similar and/or related projects
- Overall clarity and detail of proposed timeline and staff roles/responsibilities

Deliverables/measures of success (0-20 points)

- Overall clarity and detail of proposed project model
- What will be the deliverables of this contract if successful?
- How we will measure/demonstrate success?

Understanding of Identified Needs and Development of Improvement Plan (0-30 points)

- Overall demonstratable knowledge of existing community assessments and resources and clear description of how the proposed project avoids duplication and augments services.
- How will this project expand/augment services and avoid duplication of existing services? What work has your agency done to review available resources and outline gaps/barriers?
- How will this project meet the goals/recommendations outlined in this RFP and identified in the Hays County Mental Health Needs Assessment? What is the problem or challenge it attempts to solve?



• What other stakeholders need to be involved in this project in order for it to be successful and how have they been included in its design and will be included in its implementation/evaluation?

Budget, Leverage, and Financial Sustainability (0-20 points)

- Overall clarity and detail of project budget
- How will proposed expenses and/or services be sustained after the initial City investment?
- What other funding sources has the agency reviewed, applied for, vetted, etc. Please provide documentation.

Coordination/support of Continuum of Care Approach (0-15 points)

- Overall clarity and detail of proposed project's connection to a larger continuum of care
- approach
- How will this project work with/augment existing publicly-funded services (i.e. insurance reimbursements) and/or why/how is it outside of that system
- How will you design and implement culturally and linguistically appropriate services for a wide array of local needs?

Proposals should include the following information:

- Cover Letter, signed by the person authorized to bind the firm into an agreement.
- Complete legal name, address, telephone number, and email address.
- Statement of Qualifications and Previous Experience
- Proposed timeline for identifying needs and developing a plan.
- Proposed budget, partnership proposal, and/or ability to identify grants or other funding sources.
- Planned Staffing and Organizational Capacity.
- Any relevant experience collaborating with cities or counties.
- Provide one (1) original and two (2) copies of the proposal response. Only printed material will be accepted. The pages must be numbered. In addition, an electronic copy shall be submitted via email and sent to jkirkland@cityofkyle.com

Vendors are responsible for making sure they receive all addenda associated with this RFP. The deadline to submit questions is Friday, January 26, 2024 at 5:00 pm.

The City reserves the right to waive any minor deviation in proposal responses received when such waiver is in the best interests of the City, and reserves the right to modify any requirements, terms or conditions as outlined in this RFP when such modification(s) is in the best interests of the City.

Proposals will be accepted from thoroughly competent, experienced and financially qualified individuals or firms as determined solely by the City of Kyle. Consultants are responsible for the submission of accurate, adequate, and clear descriptions of the information requested. Omissions, vagueness, or inaccurate descriptions or responses shall not be interpreted in favor of the consultant and shall be grounds for rejection.

This document is not an offer to contract but is an RFP as defined herein, to satisfy specific user requirements of the City of Kyle. Neither the issuance of the RFP, preparation and submission of response, nor the subsequent receipt and evaluation of any response by the City of Kyle, will commit the City to award a contract to any consultant even if all of the user requirements in the RFP are met. The City may modify these requirements in whole or in part and/or seek additional consultants to submit responses. Only the execution of a written contract will obligate the City in accordance with the terms and conditions contained in such contract.

Consultants may be required to make a presentation of their qualifications on Tuesday, February 20, 2024, to the Mayor and City Council.

Rights to Proposals

All proposals, upon submission to the City of Kyle, shall become the City's property for its use as deemed appropriate. By submitting a proposal, the consultant covenants not to make any claim for or have any right to damages because of any misinterpretation or misunderstanding of the specification, or because of any misinformation or lack of information. Nothing contained in this RFP shall create any contractual relationship between the consultant and the City of Kyle. The City accepts no financial responsibility for costs incurred by any consultant in responding to this RFP.



The City of Kyle reserves the right to reject any and all proposals and has the right in its sole discretion to accept the proposal it considers the most favorable to the interests of the City of Kyle. In the event that all proposals have been rejected, the City further reserves the right to seek out new proposals when such procedure is deemed reasonable and in the best interest of the City of Kyle.

The City of Kyle shall not be liable for any expenses incurred by the applicant including, but not limited to, expenses associated with the preparation of the proposal; any meeting required during the selection process; presentations or interviews; preparation of the cost statement; or final contract negotiations.

All responses to the Request for Proposals will become the property of the City of Kyle.

The City of Kyle has the following prerogatives with regard to proposals submitted:

Agreement for Services

Insurance Requirements

Mental Health Proposal

Council Member Bear Heiser

Overview

- Mental Health issues continue to increase in our region, but services have not kept pace with growth.
- In May 2022, Hays County commissioned an assessment of mental health needs by the Meadows Mental Health Policy Institute.
 - Potential gaps in service and opportunities for improvement identified across an array or mental health services.
 - Most concerning, the report identified the following issues related to <u>children</u>.
 - Rising community concerns related to substance use and mental health.
 - Children with the highest needs lack access to services.
 - Youth serving providers lack coordination and collaboration.
 - Crisis response lacks resources to respond to unique needs of children, youth, and their families.
 - School personnel need additional support to address crisis that occurs in schools.

Community Needs

- According to the Meadows report, half of all mental health issues manifest by age 14, and 75% by age 24.
 - Despite this fact, individuals do not receive care and treatment until symptoms have been present for years.
 - As such, we are missing an opportunity to intervene during a time when we can have the most impact on a young person's life.
- When available, services may be in short supply, far away, or do not accept certain types of insurance.
 - Due to these challenges, many children and youth receive their first mental health treatment in a juvenile justice facility.

Community Needs (Continued)

- According to the Meadows report, approximately 40,000 children and youth in Hays County experience some type of mental health condition. These issues can be treated in the following type of care environments:
 - <u>Primary Care</u> About 8,000 or 20% of patients can have their needs addressed in a Primary Care setting (e.g. family doctor's office).
 - <u>Specialty Outpatient Care</u> Approximately 6,400 or 16% of patients need some type of specialist such as a psychiatrist, psychologist, social worker, etc.
 - <u>Specialty Rehabilitative and Crisis Care</u> Services necessary to address more serious conditions such as suicide.
- Children and youth with the highest needs lack access to intensive, community-based services.
 - According to the Meadows report, approximately 3,000 children in Hays County are estimated to have a serious emotional disturbance, and about 100 are at risk of out of home or school placement.
 - In Hays County, Hill Country MHDD is the only agency providing these types of services.
 - Average income of families served is approximately \$24.600 per year.
 - 55% of patients do not have insurance.

Proposal for Consideration

- Mental Health issues are continuing to increase for children, but we do not have sufficient resources to address the problem.
- As such, I would like to explore a partnership with the City, County, and local medical providers to increase services.
 - City of Kyle budgeted \$100,000 in FY 2023-24 for mental health services.
 - Hays County is potentially interested in participating in an agreement depending upon the structure, cost, and services provided.
 - Area hospitals could also provide grants depending on the needs identified.
 - Goal is to partner with an existing organization to provide a facility, staff, and array of services.
- <u>City Council Action Request:</u> Request that the City Manager draft and release an RFP to identify partners in the area that could assist with this issue.
 - Proposals will further refine needs and approach to the issue.
 - Focus will be to provide services to children and youth in the area.
