II. KYLE 3-1-1 IS LIVE!

Kyle 3-1-1 launched on March 11! We want to thank everyone for joining us on Saturday, March 8 at the Kyle 3-1-1 Pre-Launch Party at La Verde Park.

Residents can connect with Kyle 3-1-1 in three ways:

- **Dial Kyle 3-1-1:** Phone calls to 3-1-1, made within Kyle city limits, from a mobile phone or landline will connect residents with Customer Service Representatives available Monday through Friday from 8 a.m. 5 p.m.
- **Kyle311.com:** Our online portal allows requests to be submitted 24/7, giving residents the convenience to report and track issues at any time.
- **Kyle 3-1-1 Mobile App:** Now available to download on the Apple App Store or Google Play Store, this app allows residents to submit requests on the go, track their progress in real time and see what else is going on in the city.









III. PROPERTY IMPROVEMENT PROGRAM UPDATE

The City of Kyle, partnering with Habitat for Humanity (HFH), was able to provide long-term Kyle homeowner with some much-needed repairs.

They had lived in Kyle since 2006 and had significant home maintenance issues that were all cost prohibitive. Architectural barriers in their bathroom made bathing hazardous and heating and air conditioning equipment had been inoperable for some time. The house had broken windows, an inoperable stove, missing safety features and outdated and malfunctioning plumbing equipment. All these issues must have seemed impossible for the resident to get fixed on their own.

The City of Kyle and Habitat for Humanity were able to provide them with a walk-in shower equipped with ADA compliant grab bars, so they can bathe safely. A new heating and air conditioning system was installed to provide them with worry-free climate control for years to come. Additional improvements included replacing broken windows, installing a new commode, smoke and carbon monoxide detectors and a new range and vent hood for their kitchen. The City of Kyle's Building Department staff inspected all these repairs to ensure they were compliant with the applicable codes and would withstand the test of time. This joint venture was the first of hopefully many to come enriching the lives of the members of our community.









IV. FERAL HOG UPDATE

Last week: March 3 - 7, 2025 - Feral hogs were coming to bait consistently in the Lake Kensington area. A net-based hog trap was assembled and was active within a few days. Twenty-two hogs were trapped on the first night, and the following morning, the trapper removed the hogs. The team remotely monitored the metal corral trap in the Waterleaf area – no hogs were observed.

This week: March 10 - 14, 2025 - The team will remotely monitor the trap in the Lake Kensington area and bait if another sounder is there.

Next steps: Staff will meet with the trapper to determine the next location for the corral trap deployment. Once the next prioritized location is determined, pre-baiting will begin to move the corral trap.



V. PARKS & RECREATION DEPARTMENT UPDATES

La Verde Park Event Lawn - Maintenance Closure



Beginning March 24, 2025, La Verde Park's event lawn will close for turf maintenance aimed at improving long-term health. This includes aerating, leveling, and overseeding to enhance growth and drainage. Major work will finish by April 5, but the lawn will remain closed for up to six weeks for recovery. Updates on reopening will be provided as recovery progresses.

Gregg-Clarke Park Field 5 Renovation Completion

This past month, Field 5 at Gregg-Clarke Park underwent in-house renovations to accommodate adult league play. The infield was expanded by 15 feet, creating more space to improve gameplay and meet league standards. New infield materials were added, grading was improved for better drainage, and irrigation was reconfigured. The field has now reopened and is available for games and practices. This project, completed by staff, reflects the ongoing commitment to maintaining and enhancing park facilities for the community.



Standardized Park Rule Signs - Deployment & Installation Update



The City of Kyle is installing standardized park rule signs to promote a sustainable and integrated parks system. These signs enhance the identity of Kyle Parks, improve patron experience, and provide clear safety guidelines while minimizing clutter. Designed by iZone Imaging, the durable custom high-pressure laminate signs feature the top ten park rules in English and Spanish, along with visual icons, park hours, and contact information. Installation is underway, with completion expected by March 18, 2025, supporting the City's beautification and maintenance goals.

Steeplechase Playground - Survey Results

In late 2024, staff recognized the necessity to update the aging playground at Steeplechase Park. They partnered with Whirlix Design Inc. to develop three inclusive design concepts. Following their presentation to the Park Board and City Council, public engagement commenced, resulting in 510 survey responses, with Option 3: Modern Concept emerging as the community's preferred choice.

Next, the City Council will evaluate a contract for the new playground on March 18th, with a project target completion date of October 2025.

Gregg-Clarke Park All-Wheel Skatepark - Survey and Design Update

On March 12, design consultants began engineering and surveying analyses for the planned All-Wheel Skatepark at Gregg-Clarke Park. Fieldwork will last one week, providing essential data for the project.

Once the analysis is complete, the design team will begin developing renderings, with a presentation anticipated at a Parks Board and City Council meeting by the summer. This phase is a key step in advancing the skatepark design and ensuring a well-planned facility for the community.

Landscape Team Spotlight - Dedication to Restoration



The Parks Landscaping Team worked tirelessly to get La Verde Park back in shape after the freezes and rain. Previously, staff trimmed plants but left winter stems since many native bees will overwinter inside of winter stems. Keeping stems provided nesting sites for many native bees needing conservation help. As the spring progresses, new growth will hide the stems while providing nectar and pollen for this year's native bee generation.

Kyle Parks and Recreation Department - COED Kickball Season Report



The Kyle Parks and Recreation Department has launched a new season of COED Kickball, featuring 11 teams playing at Gregg-Clarke Park. This league offers adults a chance to stay active, engage in fun recreational activities, and build social connections. Adult kickball promotes physical activity, camaraderie, and a healthy lifestyle in an inclusive environment, encouraging community participation.

NRPA Director's School - City of Kyle Representation

From March 3–7, Parks and Recreation Assistant Director Aimee Garcia represented the City of Kyle at the NRPA Directors School in Cincinnati. This two-year program offers advanced leadership training for parks and recreation professionals. Graduates gain knowledge and tools to tackle challenges, optimize operations, and positively impact their communities. Aimee's participation is expected to enhance Kyle's parks and recreation efforts.



VI. INFRASTRUCTURE PROJECT UPDATES

Kyle Crossing/Kohlers Crossing Traffic Signal:

- Pedestrian improvements are completed with the exception of the pedestrian rail that is pending on the northeast corner.
- Grass sod and seeding completed.
- Guy wire attachments to the anchors for signal poles are being placed on all four corners.





CR 158 Elevated & Ground Storage Tanks Updates:

- Preload completing final grading for GST.
- Prota placing select fill for pump station and all density test passed.
- Submittals continue to be reviewed for approval.
- Landmark returned to completed EST pedestal to grade.
- Preload to mobilize week of March 17.

Wastewater Treatment Plant Access Road:

- Contractor placing roadbed embankment.
- Contractor levelling the ground and placing forms for the pouring of culvert bottom slab and the toe wall(s).
- Contractor hauling off road spoils.

FM 1626 Ground Storage Tank & Pump Station Updates:

- Filling GST began on March 7. Water from the existing distribution system is being used to fill the GST and will take approximately 28-45 days to be followed by hydrostatic and disinfecting testing.
- Once hydrostatic and disinfecting testing is completed the water will be fed into the distribution system.
- Installation of instrumentation communication between FM 1626 site and PW Building are completed.
- Concrete apron placement around GST exterior completed.
- AT&T has completed the installation of communication fiber.
- Well Site #4 plumbing has been completed and electrical conduits are being constructed.

Plum Creek Retail Roads:

- Preparation for Avenue A street concrete pavement has commenced.
- Avenue A concrete foundation placement for brick pavers on the trail path are underway.
- Storm box culverts are being placed along Cromwell Dr and Heroes Memorial Dr.
- Flexible Base on Avenue A being placed.





La Verde Park Parking:

- Project is substantially complete.
 Contractor is working on punch list items.
- PEC is still in process to get electric connection to the site.
