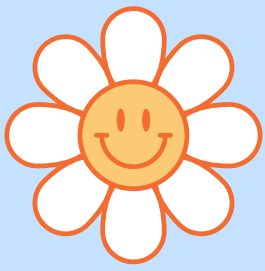

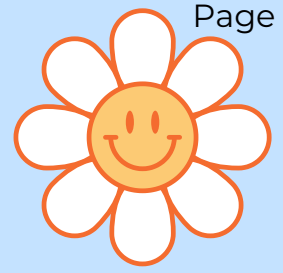

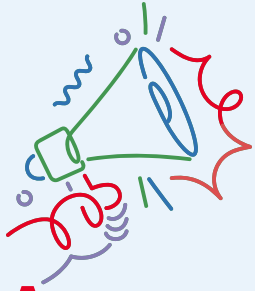

Re: Akin's Report of Activity for February 2024

Throughout February, Akin monitored both Fiscal Year 2024 and 2025 appropriations processes, **which included passage of the legislation containing \$959,752 in funding for the City's Purple Pipe Project** which Akin worked with Rep. Casar to secure. Further, we tracked relevant agency actions and funding opportunities. Finally, Jamie Tucker and Jose Borjon continued efforts to schedule congressional and federal agency meetings on behalf of the City of Kyle.

Congressional Updates

Fiscal Year 2024 Appropriations Process

The House and Senate Appropriations Committee released a bipartisan package that includes the Fiscal Year 2024 Transportation-HUD, Energy and Water, Interior, Commerce-Justice-Science, Milcon-VA, and Agriculture bills. The House cleared the package with a vote of 339-85. In the process, House Speaker Mike Johnson (R-LA) disregarded pushback from the House Freedom Caucus and rather relied on support from House Democrats to bring the bill past the finish line. The Senate voted 75-22 to send the package to President Biden, which he ultimately signed into law to avoid a partial government shutdown. As noted above, this package successfully included funding for the Purple Pipe project in Kyle.

The Appropriations Committees will now turn to finalizing the Defense, Homeland Security, and Labor-HHS bills before that funding expires on March 22. The negotiations around the second tranche of spending bills are slated to be more contentious. Of note, the Homeland Security discussions will be difficult as the House GOP impeached Homeland Security Secretary Alejandro Mayorkas and both chambers failed to find a consensus on a border deal.

Fiscal Year 2025 Appropriations Process

Despite Congress not yet finalizing its FY 24 appropriations bills, the release of the [President's budget](#) on March 11 will kick off the FY 25 process in earnest. The House and Senate Appropriations Committees have yet to release deadlines for community projects, however, individual members of Congress are posting their individual forms and deadlines. Rep. Greg Casar (D-TX) has yet to release his community project forms, but **we should be prepared to submit our requests to him in the coming days.**

Agency Updates

U.S. Department of Transportation

On February 29, the Department of Transportation (DOT) [announced](#) \$9.9 billion in federal formula funding. The funds aim to assist with the operation and maintenance of trains, buses, and ferries; upgrade stations and tracks; plan and design transit corridors, and boost access for seniors and commuters with disabilities. The state of Texas was directed nearly \$280 million in formula funding.

On February 21, the DOT [released](#) a notice of funding opportunity for the Safe Streets and Roads for All (SS4A) grant program. The program provides funding for projects that address roadway safety. Implementation grant applications are due on May 16, while planning and demonstration grant applicants may apply with the following deadlines: April 4, May 16, and August 29. The April 4 due date is the first deadline for planning and demonstration grants. The May 16 due date is the sole deadline for implementation grants and the second deadline for planning and demonstration grants. The August 29 due date is the third deadline for planning and demonstration grants and reflects when the notice of funding opportunity closes.

On February 21, the DOT [issued](#) its 2024 [National Roadway Safety Strategy Progress Report](#) (NRSS). The report outlined “allies in action”, including states whose transportation agencies and highway safety offices have voluntarily committed to bolstering roadway safety.

On February 21, the DOT [released](#) a notice of funding opportunity for the Congestion Relief Program. The grant program seeks to issue discretionary funds to states, metropolitan planning organizations (MPOs), cities, and municipalities to further innovative solutions to address congestion relief in metropolitan areas.

On February 8, the DOT [opened](#) applications for the Low- or No-Emissions Program and the Grants for Buses and Bus Facilities Program. The former program assists transit agencies in buying or leasing zero- and low-emissions transit buses, along with charging equipment and supporting facilities. The second program supports transit agencies to buy and rehabilitate buses and vans, as well as build bus facilities. Both applications are due on April 25, 2025.

Department of Energy

On February 28, the Department of Energy (DOE) [announced](#) a fourth round of selections for the Energy Efficiency and Conservation Block Grant program. The funds will support efforts to reduce energy costs, plan a green energy future, and ease energy burdens for state and local governments.

Department of Housing and Urban Development

On February 28, the Department of Housing and Urban Development (HUD) [announced](#) funds available through the Preservation and Reinvestment Initiative for Community Enhancement (PRICE) Competition. The solicitation includes \$225 million in funding and seeks to assist in the preservation and revitalization of manufactured housing and related communities. Moreover, local governments are eligible for funds. The application closes on June 5, 2024.

Department of Justice

On February 28, the Department of Justice (DOJ) [announced](#) a funding opportunity through its Evaluating Strategies to Advance the Implementation of Evidence-Based Policies and Practices program. The program seeks to support state and local governments in overseeing research and demonstration projects to boost the impact of existing crime and justice research efforts. Of note, the DOJ is interested in efforts to leverage the implementation of science and encourage evidence-based policies and practices. The funding opportunity closes on May 14, 2024.

On February 28, the DOJ also [announced](#) the Fiscal Year 2024 Second Chance Act Pay for Success Program funding opportunity. Cities and towns are eligible recipients of these federal funds. Specifically, the program seeks to fund local efforts to address reentry, reduce recidivism, and efforts to provide treatment and recovery to those involved in the criminal justice system. The application closes on April 25, 2024.
