2026 Elected Board of Directors Taxing Jurisdiction Memo

Executive Summary

Repairs on Old Stagecoach Road are underway following completion of the Heritage Oak tree relocation, with the roadway planned to reopen by New Year's Day.

Please note, due to the holidays, the next Weekly Report will be on Friday, January 9, 2026.

Construction and inspections moved forward at the Wastewater Treatment Plant, the FM 1626 Ground Storage Tank and Pump Station, and Well Site #4, supporting long-term system reliability. Wastewater line installation remained active at Plum Creek Golf Course and along Schlemmer Road, while the Center Street Village project remains paused pending final utility coordination, with construction expected to resume in early 2026.

The final ADA curb ramp in the Amberwood neighborhood was poured, marking completion of that accessibility effort. Construction also advanced at the Gregg-Clarke Skatepark, where crews transitioned from site setup into earthwork. Building upgrades continued at the Kyle Community Center, and a new solar-powered restroom was installed at Waterleaf Park, with a temporary accessible path being added until permanent trail improvements are completed.

The City received an updated construction schedule for the Kohlers and Bebee Road corridor, now under review, while construction and utility coordination continued along the corridor. State transportation officials also issued review comments on the Kohlers Crossing intersection, requiring revisions before the project can advance. Other bond corridors progressed through final design, bidding preparation, or early construction activities.

Parks and Recreation continued the 25 Days of Christmas series at Mary Kyle Hartson Park, drawing residents to holiday events including Family Fun Friday, Shopping Saturday, and Social Sunday. Santa Rides returned to Kyle neighborhoods, reaching families across multiple routes, and Grinch on the Green brought community members together at La Verde Park. Conservation staff advanced native restoration seeding at Lake Kyle, while library and staff updates included new study pods at the Kyle Public Library and the Assistant City Secretary's completion of a master's degree.

Infrastructure and Project Updates

Schlemmer & Porter Wastewater Improvements Phase 3

The contractor remains on schedule and continues installing water and wastewater lines along Schlemmer Road. The project is currently anticipated to reach completion in January 2026.



FM 1626 Ground Storage Tank and Pump Station

Work continues at the site as Archer Western installs suction header piping for the pump station. GLS is placing concrete masonry units on the pump building, while T. Morales is completing ground loop work around the generator and transformer pads. Mechanical installation progressed with air conditioning installed in the chlorine building.



Well Site #4 (La Verde)


Archer Western continued setting suction and discharge piping from the pump building this week. Electrical work advanced with wiring for lighting receptacles in the pump station, while mechanical systems were installed in both the pump and chlorine buildings. Plumbing rough-ins for the boiler unit, eyewash station, and pressure reducing zone were also completed.



CR 158 Elevated & Ground Storage Tank

Prota began excavation to prepare subgrade for roadway and parking areas as site work continues. Painting of piping inside the booster pump building remains ongoing, and Landmark placed concrete for the ground floor of the elevated storage tank while continuing exterior welding of cone sections. Electrical conduit installation to the flow meter was completed in the booster pump building.





Plum Creek Golf Course Sewer Line

SkyBlue Utilities continued installing wastewater pipe and completed cleanup activities in the section crossing the golf course. Crews also cleared vegetation within the easement to prepare for upcoming pipe installation.



Center Street Village Wastewater Improvement

The project remains on hold as the City awaits AT&T's relocation of a fiber line, which is expected on Friday, December 19. Joe Bland Construction is scheduled to remobilize and resume pipe installation in early 2026.



Wastewater Treatment Plant Early Works Package

Excavation and materials testing are ongoing at the aeration basins, clarifier, mixing basins, and disk filter locations. Rebar for the rapid mix basins was inspected and approved for upcoming concrete placement. Submittals continue to be reviewed as the project advances.



Sanders Speed Table

The contractor continued installation of the speed table this week. The demolition of the concrete pavement of the current speed table is underway. Construction is expected to be completed by the end of the year.

Amberwood Curb Ramps

The final ramp has been poured, and will be followed by the completion of pavement markings and a thorough cleanup.



Kyle Community Center

Building upgrades at the Kyle Community Center continue to move forward. Trimbuilt Construction completed underslab inspections as part of ongoing construction activities.



Gregg-Clarke Skatepark

SPA Skatepark began mobilizing equipment at the site and initiated earthwork activities. Early construction efforts are focused on site preparation.



New Waterleaf Park Restroom

A new solar-powered, two-stall restroom was installed along the Plum Creek Trail at Waterleaf Park on December 12, 2025. Park staff are currently installing a temporary ADA-compliant pathway to ensure immediate access to the facility. This temporary path will remain in place until the Vybe Trail improvements within Waterleaf Park are completed later this year, providing a permanent accessible connection.

Kohlers to Seton

Stage: Construction

An updated construction schedule was received on December 9, 2025, and is currently under City review. Right-of-way and easements are confirmed as clear, allowing construction to proceed. Utility work continues along the future IH 35 northbound right turn lane to Kohlers Crossing, as well as embankment work at the proposed Kohlers Crossing & Bebee Road roundabout.

Kohlers to Seton (IH-35 at Kohlers Crossing)

Stage: Early Design

The schematic design remains at 90% completion. TxDOT provided draft Intersection Control Evaluation review comments on December 15, 2025, and did not support the previously proposed innovative intersection option. The design team is now identifying an alternative intersection configuration to incorporate into the schematic. Completion of the 100% schematic submittal will depend on the finalized review and TxDOT direction.

Bebee Rd

Bebee Road (West)

Stage: Construction

Construction on Bebee Road (West) is advancing in coordination with the Kohlers to Seton project. Ongoing work includes: roadway embankment and stormwater drainage culvert installation along the future Bebee Road alignment, wastewater bore under Bebee, and continued excavation of the stormwater detention pond.

Bebee Road (East)

Stage: Final Design

Design for Bebee Road (East) is at 90% completion, with the 100% PS&E (Plans, Specifications, and Estimates) expected on December 22, 2025.

Center Street

Center Street (East Segment)

Stage: Final Design

Design for the on-system portion of Center Street (FM 150) is at 50% completion. The 60% PS&E submittal is expected on February 24, 2026. The TxDOT Review and Technical Coordination (RTC) meeting has been rescheduled to late February 2026.

Bunton Creek Rd

Stage: Final Design

Design for Bunton Creek Road is at 95% completion. Right-of-way offers have been sent and are currently under negotiation. Bid advertising is anticipated to begin on February 9, 2026.

Windy Hill Rd

Stage: Construction Bidding

The Windy Hill Road project has entered the construction bidding phase. Bid advertising began on December 8, 2025, and the pre-bid conference was completed on December 15, 2025. The bid opening is expected on January 22, 2026.

Kyle Pkwy/Lehman Ext.

Stage: Final Design

Design is at 95% completion, with a 100% cost-reduction design resubmittal expected on December 18, 2025. The final PS&E (bid-ready) comment-resolution meeting was completed on December 1, 2025.

Marketplace Ave

Stage: Substantial Completion

Marketplace Avenue construction is approximately 85% complete. ADA ramp work began on December 15, 2025, and Vybe Trail punch-list items are currently being addressed. Final completion is expected on December 25, 2025.

Restoration Seeding at Lake Kyle


