### II. STAYING INFORMED ON THE 89TH TEXAS LEGISLATURE

As the 89th Texas Legislature moves forward, staying informed on legislative developments is crucial. For anyone who may be interested, Texas Municipal League (TML) Legislative Update website (see below) provides weekly insights into key legislation, including:

#### III. FERAL HOG UPDATE

Last week: January 27-31, 2025 - A small sounder consisting of 8 hogs was captured the morning of January 27, 2025 in the Waterleaf area. They were removed by the trapper that day. After captured hogs were removed from the trap, another sounder came to the bait that night at the same trap site. Therefore, baiting will be continued at that same location to capture this sounder to get them accustomed to entering the trap. When they all enter, the trap will be triggered.

**This week: February 3-7, 2025 -** It is expected that the latest sounder coming to bait will be captured and removed.

**Next steps:** There have been residents reporting hog sightings along the Plum Creek corridor to the Northeast of Waterleaf. The trapper and the PARD Conservation Division Manager will assess locations to determine where to focus efforts next if hog activity has been diminished in the Waterleaf area.



#### IV. PARKS & RECREATION DEPARTMENT UPDATES

### **Staff Training and Development**

Parks and Recreation team members attended the annual Southwest Parks and Recreation Training Institute, held at Quartz Mountain State Park from February 2-5, 2025. The mission of the Institute is to present and promote educational opportunities to students, professionals, and lay supporters of the broad field of Parks and Recreation.



Additionally, Conservation Manager John Davis, and Business and Strategic Manager Tamara Aquino were featured session presenters at the conference, contributing to discussions on key industry topics and best practices. They represented Kyle proudly and professionally as subject matter experts.

### Upcoming event season calls for local vendors



The Parks and Recreation Community Events team is preparing for the upcoming event season by coordinating with local vendors and partners. They are securing permits, finalizing schedules, and confirming staffing.

Vendor applications are now available through <u>KyleRec.RecDesk.com</u> for those interested in participating. The season begins on March 4 with the Mardi Gras Celebration at La Verde Park.

### Kyle Parks and Rec applying for the TxDOT Alternative Transportation Grant

The City of Kyle is seeking funding from the TxDOT Alternative Transportation Grant to build a 0.5-mile segment of the Vybe Trail, linking Interstate 35 to Steeplechase Park. The grant process has two phases: an initial application for project eligibility followed by a comprehensive application after TxDOT's invitation. This 80/20 reimbursement grant allows the City to cover 20% of costs and receive 80% reimbursement, optimizing public fund allocation for community infrastructure. The preliminary application is expected to be submitted before the February 21, 2025 deadline.

### Balancing Safety and Sustainability: Clearing a Fallen Tree While Supporting the Ecosystem

The Trails Crew recently cleared a fallen tree blocking the pathway along the trail behind Waterleaf to ensure safety for trail users while leaving most of the tree intact to decompose naturally, benefiting the local ecosystem. Key ecological benefits include:

- Habitat for wildlife, providing shelter and food.
- Soil enrichment from nutrient release during decomposition.
- Erosion control by stabilizing the area and preventing runoff.

### **Seasonal Hiring Begins**

The Kyle Parks and Recreation
Department launched its first one-day
hiring event on February 5 for
seasonal recruitment for camp and
aquatic positions. Attendees had onsite interviews and could apply
without pre-registration.



Two more events are scheduled for February 19 and March 12 at James Adkins Pool, 1100 W Center Street. All interested candidates are encouraged to attend and apply!

#### V. INFRASTRUCTURE PROJECT UPDATES

### FM 1626 Ground Storage Tank & Pump Station updates:

- Installation of instrumentation for ARWA meter site and GST continues.
- Contractor continues to install piping for ARWA connection.
- AT&T has initiated construction for replacement of the underground cables with overhead lines.





### CR 158 Elevated & Ground Storage Tanks updates:

- Prota Inc. continues to excavate for GST.
- Submittals are currently being accepted and reviewed for approval.
- Prota Inc. continues to work on the entrance road off of CR 158.
- Project signs are being prepared for placement on site.

### Waterstone (CR158) Pump Station:

- Construction of the entry road from CR158 is in progress.
- Site work is ongoing, which includes environmental controls and excavation for the ground storage tank (GST).
- The project will be carried out in phases:
  - <u>Phase I</u>: Construction of a 500,000-gallon ground storage tank and pump station, anticipated to be completed by October 2026.
  - <u>Phase II</u>: Review of the schedule for a 1 million-gallon elevated storage tank is currently underway.





### Anthem (Hoover) 1 MG EST:

- Welding of the exterior roof sheets completed.
- Interior floor sheets have been welded.
- Hand rails and roof vents have been welded.

#### Wastewater Lift Stations Currently Under Construction:

- Waterstone: Now in service, with final punch list items being addressed.
- Crosswinds 6B: Accepted by the Council on January 21, 2025.
- Freedom: Startup completed, with punch list items still pending.



### Wastewater Treatment Plant Access Road:

- Cage and Cade moved in equipment.
- Silt fence and erosion control measures installed.
- Contractor has begun clearing the property, 40 feet in width, for preparation of the detour.

### Kyle Crossing/Kohlers Crossing Traffic Signal:

- Weather delays during the week.
- Sidewalk poured on the southwest corner of the intersection.
- Northwest corner framing and leveling are underway in preparation for the concrete pour.
- Contractor extending drainage pipe on southeast corner of the intersection.





### La Verde Park Parking:

- Project is substantially complete. Contractor is working on punch list items.
- PEC is still in process to get electric connection to the site.

#### Plum Creek Retail Roads:

- Weather delays during the week.
- Weather permitting, water line and reclaim water line installation continues on Cromwell to Heroes Memorial Drive.
