# FM 1626 Ground Storage Tank & Pump Station:

- Excavation of 16-inch water line exposed three AT&T fiber cables outside its documented location.
   Field meeting scheduled with AT&T Wednesday at 1:30 pm.
- 811 has located and marked the location of the fiber cables across the limits of construction.



- Archer Western continues to work carefully around the fiber.
- Full onsite mobilization of preload on August 12.
- Archer Western work schedule 7am 7pm, Monday- Friday.



#### **Plum Creek Retail Roads:**

- Subgrade embankment being placed along Avenue A between Everett and Burnham.
- Utility trenching in progress along Avenue A between Everett and Burnham.
- Waterline being placed and chlorination testing is pending along Everett between Doherty and Avenue A.
- Subgrade shaping is in progress along Cromwell between Avenue A and Doherty. Utility adjustments are needed along Cromwell between Avenue A and Doherty.

#### Heidenreich Road:

- Project is complete as of July 26.
- Project Scope was a Full Depth Mill and Overlay of 1.31 Ln Miles from FM 150 north to County Line
- Striping is included with the striping contract approved on July 16 and should commence soon.

- Project Scope was a Level up & Overlay of 1,670'x22' of Old Stagecoach Rd from 6 Creeks Blvd to Veterans Dr.
- Striping is included with the striping contract approved on July 16 and should commence soon.

# La Verde Park Parking Lot:

- Pay request show project is 6.5% complete.
- Site rough grading is approximately 90% complete - to continue until August 6.
- Mobilizing utility crew to start locating existing utilities this week.
- No weather days were recorded.



Re: Akin's Report of Activity for July 2024

Throughout July, Akin monitored relevant grant opportunities and provided guidance on the City of Kyle's current grant applications. Moreover, we scheduled and assisted with meetings for Sens. Cruz and Cornyn and Reps. Casar and Roy in Washington, D.C. Additionally, Akin coordinated a meeting with the Department of Transportation Federal Railroad Administration to discuss Kohler's Crossing grade separation. Additionally, Akin engaged with new staff in the DC Office of Union Pacific to compliment the efforts of the city with UP staff in Texas. Finally, Akin worked with Rep. Casar's office on his visit to present community project funding to the city.

#### **Congressional Updates**

#### Fiscal Year 2025 Appropriations Process

The House of Representatives has stalled on the appropriations process. Of interest to Kyle, the House passed the Interior-Environment spending bill 210-205 on July 25 and Energy-Water was not brought up for vote on the floor. The Senate continued its appropriations process holding committee markups on July 25 and on August 1. The Interior-Environment and Energy-Water bills were reported out of Senate Committee. A continuing resolution is expected to be passed in September upon return from the August recess.

#### **Agency Updates**

#### U.S. Department of Transportation

On July 9, the Department of Transportation's (DOT) Federal Railroad Administration issued a funding notice for over \$1.1 billion in Railroad Crossing Elimination (RCE) grant program funding. The RCE invests in projects that construct grade separations, upgrade safety devices, or close at-grade crossings where roads and tracks intersect. Project applications are evaluated on safety improvements, community connectivity, access to emergency services, and goods mobility. The RCE Program funding will set aside at least 20 percent for rural or Tribal lands and \$38 million for planning projects.

On July 3, the DOT <u>announced</u> the third round of the Reconnecting Communities Pilot (RCP) Program, containing more than \$600 million for capital construction and community



planning grants. This funding is supported by the Bipartisan Infrastructure Law (P.L.117-58). Interested communities can request free technical assistance through DOT's Reconnecting Communities Institute to explore project feasibility. The <u>application</u> deadline is September 30, at 11:59 PM.

#### U.S. Department of Interior Bureau of Reclamation

On July 24, the Bureau of Reclamation posted a Notice of Funding Opportunity for the <u>WaterSMART Drought Response Program</u>. The grants are eligible for states, tribes, and local entities to increase water supply reliability through investments in existing infrastructure. The grant program supports proactive approaches through drought plans and long-term drought resilience projects. The <u>applications</u> are due on October 7, by 4:00 PM.
