Otters Spotted Playing In Lake Kyle



North American River Otters were recently spotted at Lake Kyle.

North American River Otters once ranged across much of Texas. Pressure from the fur trapping industry reduced their populations drastically by the late 19th century. However, nature is often resilient.

Since trapping pressure has decreased, their numbers have begun to rebound and these beloved animals, well-known for their playful disposition, are moving westward across Texas into historic ranges.

Highly adaptable, though preferring clean waters, this species is never overly abundant in any location due to its habit of roaming sizeable home ranges (3-15 square miles). So, spotting these elusive animals in our city park is certainly a treat.

River otters eat various species of animals smaller than themselves, but their favorite meal is crayfish or "crawdads". They typically have an average of 2 pups during winter/early spring in southern states and den in underground burrows in banks or beneath fallen trees or root wads.

The latest sighting was documented a few weeks ago in iNaturalist by local citizen scientist, Shelia Hargis, as she conducted volunteer wildlife surveys at Lake Kyle Park. <u>View her observation</u>. This highlights the importance of such volunteer efforts and the technological tools that allow scientists to gather useful data from the thousands of wildlife enthusiasts who enjoy our parks.

III. INFRASTRUCTURE PROJECT UPDATES

FM 1626 Ground Storage Tank & Pump Station:

- 16-inch outlet line pressure testing completed.
- GST contractor will complete all tank wall panels by Thursday, Sept 9th. Installing forms for placement of concrete floor.
 Friday September 20 a start time of 12
 AM for placement of concrete to GST floor. Time to complete pour is estimated at 3-4 hours.



- Archer Western and Preload work schedules 6:30 am- 4:30 pm, Monday-Friday.
- Coordination meeting with K. Friese for Marketplace Ave street reconstruction was held on Friday Sept 13th. Placement of the 3-inch force main from the intersection of FM 1626 and Marketplace Ave to the existing manhole will be added to the Marketplace Ave contract due to scheduling.

Alliance Segment C Updates:

Work Completed Last 2 Weeks:

- Crew A finished laying pipe from Dacy Lane up to I-35.
- Crew B continues laying pipe to the south of Lehman HS towards. Hwy 150; nearing Plum Creek crossing on eastern side of the Walton Property.
- Microtunnel under I-35 south of Beebee Road is complete.
- Continued with hand tunnels in various locations; there are five crews completing these tunnels.
- Currently hydrostatically testing the 12-inch waterline.

Upcoming Work Next 2 Weeks (9/23 & 9/30):

- Crew A continue laying pipe to the west of I-35, expected to lay 2,000 feet of pipe.
- Crew B continues laying pipe to the south towards Hwy 150, expected to lay 500 feet of pipe.
- Mobilizing microtunnel machine to the I-35 crossing near Waterstone.
- Hand tunnelling for various crossings will continue.



Plum Creek Retail Roads:

- Storm drain line C installation in progress along Avenue A.
- Storm drain collars and inverts at junction boxes and inlets have been poured between Burnham to Cromwell Dr.
- Concrete driveway removed for future asphalt entrance per plans at FM 1626.
- Embankment work completed along Avenue A.
- Duct bank work in progress along Avenue A.
- Wastewater line B installed along Cromwell Dr, including three cleanouts and two manholes.

La Verde Park Parking Lot:

- Curb Bluetops were set and graded on September 9.
- Retested density test on the first course.
- The concrete crew mobilized on September 12 and began setting pins for the curb.
- Started pouring the curb on September 13.
- The curb installation is ongoing through September 20.
- Dry utilities planning to start on September 18.
- Curb backfill September 16.
- No weather days were recorded.
